THIS AGREEMENT AFFECTS YOUR LEGAL RIGHTS; PLEASE READ IT CAREFULLY AND SIGN ONLY IF YOU UNDERSTAND AND AGREE TO ITS TERMS

1. **Parties and Term:** This Release Agreement is made between Pebble Beach Company, Pebble Beach Concours d'Elegance®, The Lodge at Pebble Beach™, as well as its affiliates, insurers, officers, directors, employees, agents and representatives, owners and parent companies, partnerships, subsidiaries, assignees, and all other facilities owned by Pebble Beach Company (collectively "PBC") and the undersigned (the "VOLUNTEER"), and is to remain in effect from the date of execution through September 1, 2017. The term "VOLUNTEER" as used in this agreement describes me, and I intend that it also describe and include my insurers, heirs, and assigns.

2. **The Activities Covered by the Agreement:** VOLUNTEER desires to participate as a volunteer in the 2017 Pebble Beach Concours d'Elegance® which will be held from August 14, 2017 through August 21, 2017 at Pebble Beach Resorts® (the "Event"). I understand that the Event will occur in a natural locations ("Locations") which may contain hazardous or dangerous conditions and involves physical labor, including but not limited to, field set up, field operations, field security, field transportation, and host, retail, guest and customer interactions (the "Activities"). In consideration for execution of this agreement by VOLUNTEER, PBC agrees to allow access to its property and facilities for the purpose of participation in the Activities described herein and for participation in the Event.

3. **Media Release and Recognition of Trademarks:** You may not photograph, film, tape, or aid in transmitting in whole or part, any picture reproduction, description or account of the Pebble Beach Concours d'Elegance or related events of Pebble Beach Automotive Week for commercial purpose without prior written consent of Pebble Beach Company. You also agree and understand this is a public event that will be photographed and digitally recorded by Pebble Beach Company and you permanently assign and release any and all rights related to those photographs and recordings (or any manipulations or variations thereof) to Pebble Beach Company and its affiliates for their commercial, editorial and other uses.

4. **My Agreement to Assume the Risks Associated with the Activities:** I as the VOLUNTEER understand that there are risks associated with the Locations and Activities described in this agreement. Specifically, I understand that there are risks of bodily injury, property damage, or even death, due to, but not limited to, slips and falls, strains and sprains, vehicle accidents, physical exertion, injury from dropping, lifting, or from use of various tools and equipment, or materials of both natural and artificial nature, exposure to outdoor elements, and from other dangers that are both foreseeable and unforeseeable.

I ACKNOWLEDGE THAT THE ACTIVITIES REQUIRED TO VOLUNTEER REQUIRE PHYSICAL EXERTION AND VARIOUS NATURAL AND MANMADE CONDITIONS, BOTH IN AND OUTDOORS, WHICH COULD BE DANGEROUS AND RESULT IN POTENTIAL BODILY INJURY AND DEATH, AND I AM WILLING TO, AND HEREBY DO, EXPRESSLY AND VOLUNTARILY ASSUME ALL SUCH RISKS FOR MYSELF.

5. **My Agreement to Release PBC from Liability:**
IN EXCHANGE FOR THE CONSIDERATION OF BEING ALLOWED TO VOLUNTEER AT PBC, I AS THE VOLUNTEER, HEREBY RELEASE PBC FROM AND AGAINST ANY CLAIMS (SPECIFICALLY INCLUDING CLAIMS FOR PERSONAL INJURY, PROPERTY LOSS OR DAMAGES, AND WRONGFUL DEATH), DEMANDS, LOSSES, COSTS, EXPENSES, OBLIGATIONS, LIABILITIES, DAMAGES, RECOVERIES, AND DEFICIENCIES, INCLUDING, WITHOUT LIMITATION, INTEREST, PENALTIES, AND REASONABLE ATTORNEYS' FEES AND COSTS (THE "CLAIMS") THAT PBC MAY INCUR OR SUFFERED THAT ARISE OR RESULT FROM OR ARE RELATED TO THE ACTIVITY, OR THIS RELEASE AGREEMENT, REGARDLESS OF WHETHER THE SAME SHALL ARISE BY THE NEGLIGENCE OF PBC. I ACKNOWLEDGE THAT PBC WOULD NOT AGREE OR ALLOW PARTICIPATION IN THE ACTIVITY WITHOUT THIS RELEASE AGREEMENT.
