

Position: Community Impact Director, Financial Stability

Summary: The Community Impact Director, Financial Stability oversees and implements UWMC's asset building and affordable housing programs through partnerships, grant making, direct service, and advocacy. The incumbent will serve the needs of diverse communities by being a leader in providing promising community programs that target underserved populations and communities. This position will prioritize equity by supporting historically and socially disadvantaged communities to be economically self-sufficient, with more opportunities for prosperity. In addition, the incumbent will include, collaborate and co-create with program beneficiaries on program design and implementation. These programs and services are supported by grants from foundations, government contracts, corporate and individual donors.
