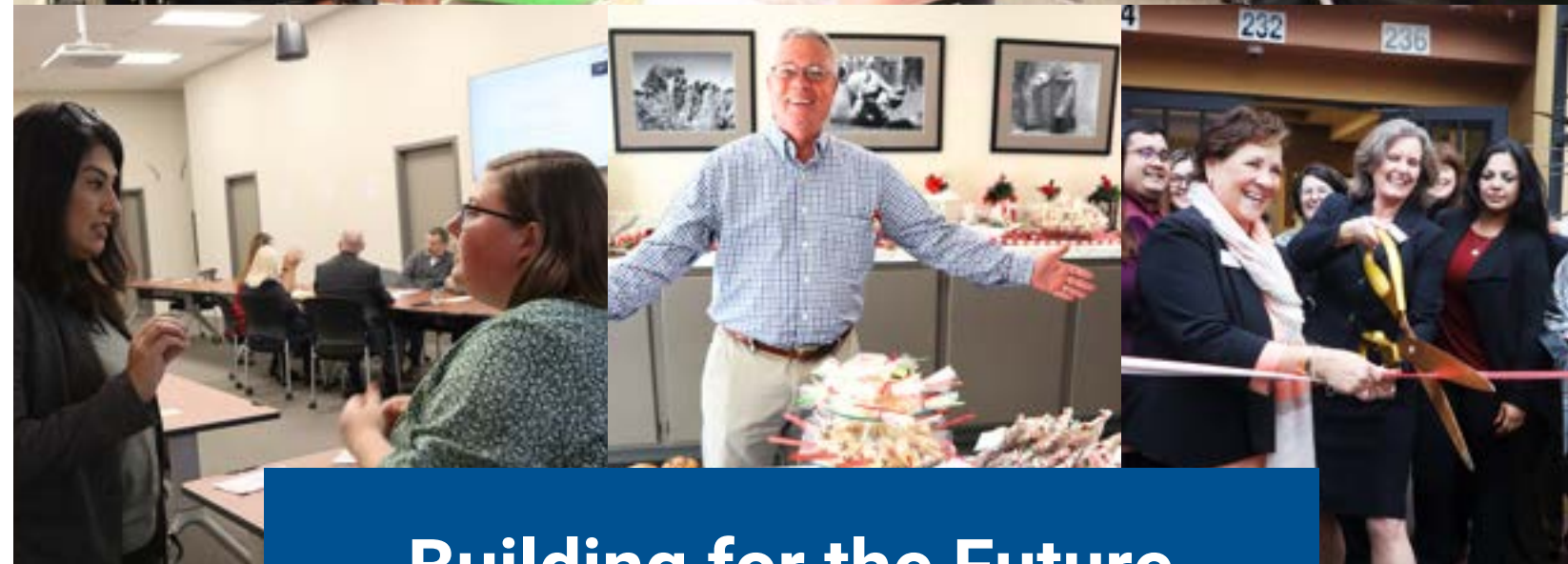

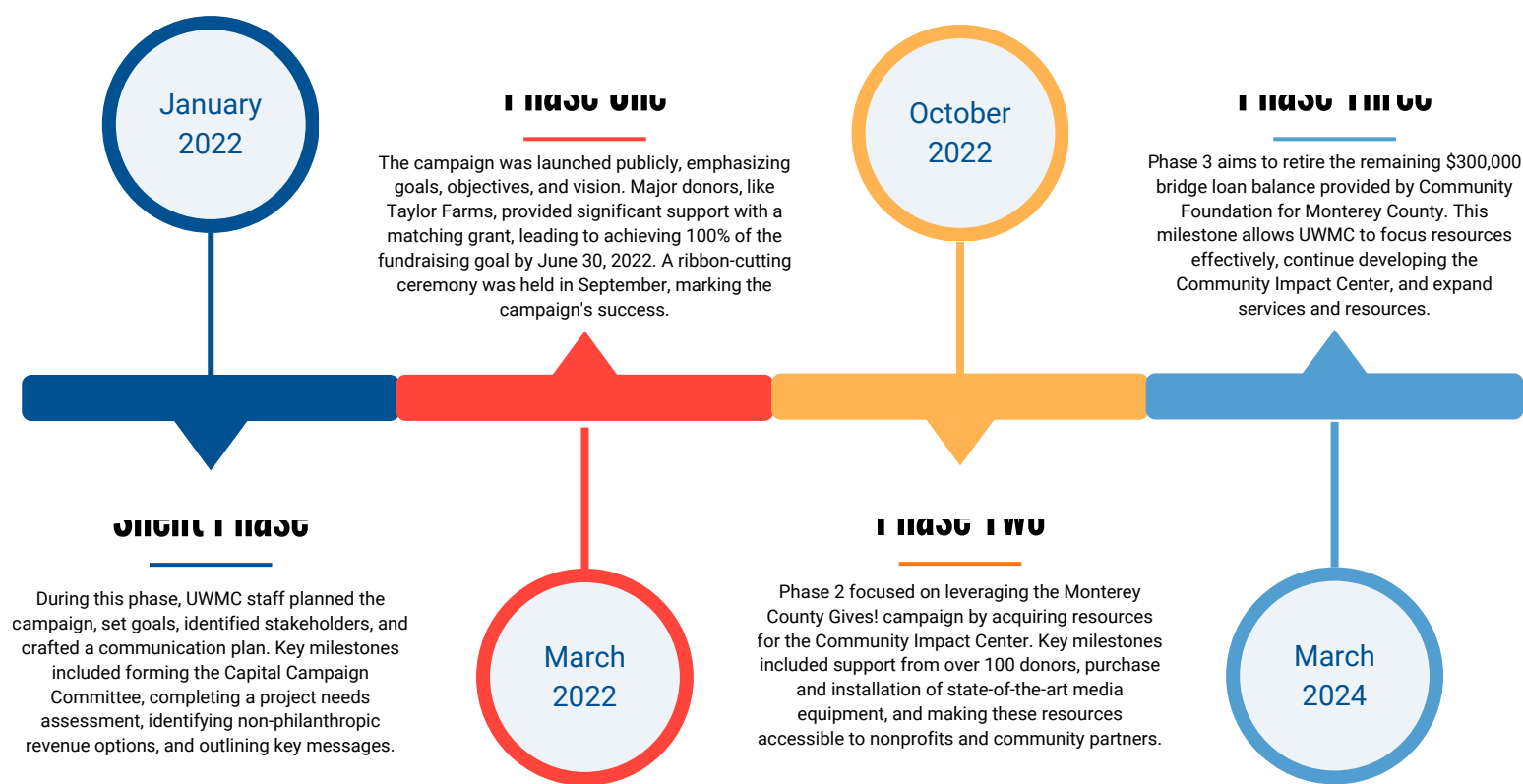
Building for the Future

On June 30, 2022, United Way Monterey County (UWMC) achieved a significant milestone with the acquisition of the United Way Monterey County Community Impact Center, successfully completing Phase 1 of our *Building for the Future* Capital Campaign.

In the past year, as we embarked on Phase 2 of our campaign, our focus turned toward enhancing the Center's capabilities. **Through the generous contributions of our supporters, we have been able to fund state-of-the-art Audio Visual equipment and cutting-edge meeting technology.** This transformation has positioned the Center as a unique community meeting space, hosting over 40 nonprofit organizations and community groups since its inception. We are proud to have created a space that fosters collaboration and community engagement.

We now shift our efforts to ensure that our financial resources are directed toward community programs and initiatives by retiring some debt and are excited to launch Phase 3 of the Capital Campaign.

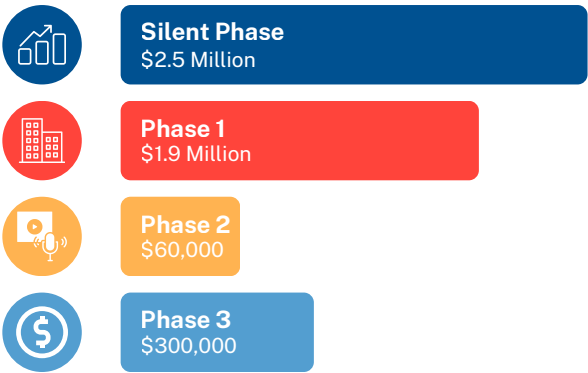
HOW YOUR CONTRIBUTION HELPS
