## Summary of Position:

In collaboration with team members and the Director, this position leads United Way Monterey County's (UWMC) Volunteer Income Tax Assistance (VITA) program and supports other asset building programs for low to moderate income taxpayers as well as individuals with limited English proficiency in Monterey County. VITA volunteers provide free tax services at community and neighborhood locations so that taxpayers receive their full federal and state refund to pay expenses, reduce debt, and increase savings. Typically, the VITA program engages over 100 volunteers to support residents to complete tax returns.

## **Responsibilities and Duties:**

- Develop and implement VITA Service Delivery Plan to ensure program sites are accessible to clients, consistently staffed with trained volunteers, and able to meet program goals.
- Collaborate with local and county partners including the IRS, colleges, universities, and other organizations to draft and implement agreements for tax sites, volunteer recruitment, training, site management, client outreach, and other activities for the VITA program.
- Work with IRS partner and local volunteer instructors to develop and implement Volunteer Training Plan with in-person and online options that enable volunteers to provide professional, high-quality service to clients.
- Develop and implement volunteer management plan to recruit, train, schedule, recognize, and retain volunteers during and after tax season.
- Work with marketing team to develop program materials for training, marketing outreach, and fundraising.
- Present to diverse audiences on program topics such as the VITA program and eligibility for the Earned Income Tax Credit and Child Tax Credit.
- Track grant application and reporting deadlines and ensure timely submission of reports required by funders of UWMC programs.
- Support UWMC program proposals and fundraising activities.
- Other duties as requested.
